Contract Terms:

Service Location/requirements: Location of service for the day-of-event will be at the discretion of the client. A set-up table/work area needs to be made available for the Makeup Artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. In the event of airbrush application, there also needs to be a 3-prong outlet available for use.

Liability: Makeup Artist's obligation to give services hereunder is subject to the unavailability of the Artist as a result of extreme illness, accidents, acts of God and other reasons beyond the Artists control.

Delays: : A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for a scheduled time or if scheduled makeup exceeds allotted time because of client delays.

Travel Fee: A travel fee will be applied in addition to service charges. The fee is \$20 per hour round trip to the day-of-event location, to be determined by the bride.

Cancellation Policy: A cancellation must be submitted in writing within 30 days of scheduled event. If client fails to do so within the appropriated time payment in full, as agreed upon in this contract, is required.

Service Prices/Fees:

Airbrush Makeup Application: \$125 (includes false lash application)

Cream Foundation Application: \$80

False Lash Application: \$15

Booking Fee: \$50 non-refundable

Payment: A non-refundable booking fee of \$50 is required to secure your selected service date. Final payment is due in full at the time of service, no exceptions. Acceptable payments are to be made via cash, check, or credit card. Receipt of payment will be sent via email if requested.
